Whereas the Author of the Trust established a Public Charitable Trust in the name and style of "**G.K. FOUNDATIONS**" as per the Registered Deed of Trust dated 28/07/2010, registered as Document No. 833/2010 on the file of the SRO, Walajapet, for the objects and purposes mentioned, in the said Trust Deed and for that purpose she has also set apart a sum of Rs. 1,001/- (Rupees One Thousand and One only), which she handed over to the Trust with all the income arising therefrom and all the accumulations and accretions thereto for the purpose and objects therein;

Hence she is executing this Amended Deed of Trust with the following Terms and Conditions:-

1) The Name of the Trust shall continue to be :

2) The office of the Trust shall be at No.1B, Vakil Street, RANIPET, Walaja Taluk, Vellore District, or such other place or places as the Trustees may decide from time to time

3) The objects of the Trust shall continue to be as follows:

a) To establish, maintain, manage and run Schools, Arts and Science Colleges, Professional Colleges, Polytechnics, Technical Institutes, and other educational institutions;

b) To establish, run, maintain and manage Hospitals, Medical/Health Centres, Youth Centres, Orphanages, Home for the Aged and Children and other Philonthropic institutions;

c) To institute Studentships, Scholarships, Stiphends Medals, Prizes, etc., to encourage deserving students;

d) To do all other acts and deeds as are incidental and conducive for the attainment of the abovesaid objects or any one of them;

4) The Trust hereby created shall be IRREVOCABLE ;

5) The term " Trust Property" shall mean and include the said sum of Rs. 1001/- (Rupees One Thousand One only) set apart by the Author of the Trust and further grants, donations and contributions of money and /or property moveable or Immoveable that may be made by the Author of the Trust or by others from time to time and other accumulations and accretions thereof in whatsoever form they may be varied from time to time.

6) The Trust property shall vest in the Board of Trustees who shall hold, manage and administer the Trust in accordance with the terms and provisions thereof;

7) The Board of Trustees shall consist of the following Trustees:

8) The abovesaid Trustees shall hold their office for life. They may elect One Managing Trustee, One Secretary and One Treasurer as Office-bearers of the Trust from among themselves once in Three years and such office-bearers shall also be eligible for re-election.

9) The Board of Trustees shall by majority take all Policy decisions of the Trust, while the day to day administration of the Trust shall be taken care of by the Secretary of the Trust under the advice of the Board of Trustees. The Trustees shall meet atleast once in Three months to take decisions on the activities of the Trust;

10) The Managing Trustee of the Trust shall preside over all the meetings of the Board of Trustees. In the event of tie, the Managing Trustee shall have casting vote;

11) The Secretary of the Trust shall manage the affairs of the Trust under the advice of the Governing Body and he/she shall also convene all the Meetings of the Trust and shall maintain proper minutes of such meetings.

12) The Treasurer shall maintain all the accounts of the Trust and maintain proper vouchers and records of all expenses incurred.

13) The Financial year of the Trust shall be from 1st April to 31st of March of every year;

14) The Trustees shall from time to time after meeting the expenses of and incidental to the management of the Trust property and of the Trust, decide the particular object or objects for which the income or corpus of the Trust fund or properties for the time being available shall be applied;

15) The Trustees shall keep an account or accounts with any of the Nationalised or Scheduled banks which may be decided from time to time in the name of the Trust and such account or accounts shall be operated jointly by the Secretary and the Treasurer;

16) The Trustees may from time to time frame Schemes and Rules and Regulations to carry out the objects of the Trust and for managing the affairs of the Trust and to vary the same from time to time as the Trustees may in their discretion deem fit and proper.

17) The Trust shall have power to acquire, purchase, take on lease, accept gift, exchange or sell mortgage, lease out any property movable or immovable in the name of the Trust.

18) There is no Immovable property involved in this Deed of Trust and as such no conveyance of Immovable property is done through this instrument;

19) The funds of the Trust, after being utilized for the promotion of the objects of the Trust in the financial year, be deposited in any mode and in accordance with the provisions of Sec.13(1) (d) read with Sec.11(5) of I.T. Act 1961. Further, not more than 5% of the Income of the Trust shall be applied for any religious purpose or be given to religious institutions;

20) The Secretary shall be the Chief executive Officer of the Trust and he/she shall have all powers to deal with the State, Central, Govt., Departments and N.G.O. Agencies Land Reg., Income Tax, Commercial Tax, Central Excise, Postal Dept., E.B. and in all legal proceedings;

21) The Accounts of the Trust shall be maintained regularly for every financial year and the same shall be audited by a qualified Chartered Accountant every year.

22) The Income and funds of the Trust shall be utilized towards the objects and no portion of it shall be utilized for payment of Trustees by way of Profits, Interest, Dividends, etc.,

23) The Trust shall be Irrevocable for any reason and under any circumstance, whatsoever.

24) No alienation of Immoveable property shall be done without the prior approval of the Director of Income Tax (Exemptions);

25) The Trust shall not carry on any activity with the intention of making profit;

26) The Trust shall not carry on any of its activities outside the territories of India and the same shall be carried on without any discrimination of caste, creed, colour or religion;

27) Any clause or provision of this Deed of Trust shall be altered or amended by majority of the Trustees and such alteration/amendment shall come into force only with the approval of the Director of Income Tax (Exemptions) having jurisdiction over the Trust;

28) No immoveable property of any nature is being transferred through this Deed of Trust;
